My apologies for the lateness of this circular but many things have kept me extremely busy since the Inaugural Conference of IFPRA Asia Pacific which was held in early October 1990, in Adelaide, South Australia, in conjunction with the Annual Conference of the Royal Australian Institute of Parks and Recreation. The Congress was most successful and the delegates both from overseas and Australia found it very worthwhile indeed.

I have received two reports, one from Dr Kanzo Hirano, Executive Director of IFPRA Japan and the other from Mr Samuel Penafiel, OIC Parks, Protected Areas and Wildlife Bureau from the Philippines.

#### Report of Adelaide Congress and Study Tour by Dr Kanzo Hirano

It was an exciting trip for us all to visit Australia to take part in the RAIPR's Annual Congress and IFPRA Regional Conference for IFPRA Asia Pacific and to visit several cities aiming to find out how Australian parks are designed and managed.

#### Congress in Adelaide, South Australia

The congress was well organised and useful for us all. The number of participants, 425 domestic and 65 foreign, was sufficient to make the Congress successful and satisfactory. I heard reports that sessions were so impressive and instructive as to be evaluated as being wonderful. I believe that the success of this Congress was brought about by thorough preparation including appropriate choice of theme, and the distribution of information on the sessions among delegates.

I must express my greatest thanks and pay heartful respects to Mr Peter Nicholls, the President RAIPR, Mr Don Marriot, Congress Chairman and all other members of the organizing committee of the Congress.

#### IFPRA Asia Pacific

I should express my pleasure for all on the establishment of IFPRA Asia Pacific. The regional organization was shown to have been formed by more than 64 people attending from the Asia Pacific region. I believe that this successful result was brought about mainly by Trevor Arthur, Acting Secretary of the Region. The number of countries represented by Commissioners from IFPRA Asia Pacific, at this moment, is too small, only six. This must be increased in the near future by making this new organization more active.

Cooperative efforts must be made before the Hong Kong Congress in 1992. I think it is quite important to make continuous contacts with non member nations and ask them to come and join us.

#### First Asian Congress of IFPRA Asia Pacific

The proposal that regional Congress in 1993 should be held in Japan was approved by all Commissioners present. I hope this positive attitude of members will make this new organization more vigorous and helpful to us all. The newly established organization of IFPRA Japan, the first chapter of IFPRA, is ready to organize the proposed first Asian Congress of IFPRA Asia Pacific in 1993 and will shortly be making friendly contacts with potential delegates.

#### Study Tour of some Adelaide Cities

Well, it was the first visit to Australia for most of the study tour members from Japan. Our trip commenced by visiting the city of Perth, followed by attending the Congress in Adelaide. Next we visited Canberra, then Melbourne and finally Sydney. In every city we received a heartfelt and warm welcome, and were given excellent professional talks and written documents. All of us were impressed with the wonderful landscapes and well managed park systems. These together with the top class beef steaks and delicious wine and warm hospitality have made us want to come back again to Australia. I believe that this kind of professional exchange would open the windows of mutual understanding among both the professionals and technicians responsible for park and recreation. This is the first step for the future development of professional exchange in the related fields.

Our greatest thanks must be given to Mr Trevor Arthur who made the arrangements for our technical visit in the cities mentioned above. We owe it to both organizations of RAIPR and IFPRA that our study tour was successful.

### Need for more Meetings - Study Tours

I would like to conclude my report by summarizing topics to be considered. It should be quite important to promote our mutual understanding and exchange professional knowledge and experience through international Congresses, Conferences, meetings, seminars, symposia and study tours. All this professional exchange will produce great fruits for the benefit of the communities we serve.

Mr and Mrs G. Shearwood in Perth, Mr G. Jones in Adelaide, Mr P. Harrison in Melbourne, Mr J. Laity in Canberra, Mr J. Mortimer in Sydney and the others who showed us parks can never be forgotten because of their hospitality and the many kindnesses we received which helped to make our visit so enjoyable, professionally rewarding and successful.

### Report of Adelaide Congress by Mr Samuel Penafiel.

#### Impressions on the RAIPR and IFPRA Meeting

While in Adelaide and Melbourne, I was impressed by how the Australians had developed parklands which provide them with such pleasant areas for outdoor recreation. This must be the product of a prestigious group of park and recreation professionals within the Royal Australian Institute of Parks and Recreation. The existence of RAIPR and IFPRA in Australia certainly provides a professional group who could influence policy and decision makers as well as the residents in the communities to create for themselves parklands and recreation areas for wholesome living.

The diversity of animals, plants and landscape architectures in Australian parklands I visited provided me with leisure and entertainment from nature.

#### Conference

The RAIPR-IFPRA meeting was a big success as far as my expectations during the four day meeting cum symposia. The meeting provided me with insights on how developed countries design and develop their parklands both in the city and in suburban areas. The case studies and presentations on issues pertaining to use and conservation provided me with ideas on how to resolve and approach similar problems in the Philippines. Social and economic factors that affect park and recreation are very much different from Australian conditions. Our parks are often heavily used by low income people and are under a great deal of pressure.

#### Need for Exchange of Information

I hope IFPRA could promote further the networking and exchange of information among countries through its newsletters and future meetings so that regional efforts in national parks and recreation administration can be carried out under the guiding principles of sustainable development.

#### Conclusion by Trevor Arthur

May I on behalf of the Royal Australian Institute of Parks and Recreation, including myself, warmly thank the delegates from overseas who contributed so much to the success of the Conference. The Conference was presented with two fine papers from IFPRA Asia Pacific members, one by Dr K. Hirano and Dr Y. Tashiro from Japan, who jointly presented a paper entitled "The Development Process of Urban Parks in Japan in the Context of Planning, Past Present and Future."

Mohammed Al-Humaidhi from Saudi Arabia presented a paper entitled "Major Conflict in Coastal Management in Saudi Arabia." A special vote of thanks to these three members for their hard work in preparing and presenting papers in a foreign language. Well done!

Mixing with Australian delegates, sharing information and learning some of the problems that beset parks and recreation activities worldwide, learning something of the cultures, management practices and the delightful landscapes of many overseas parks, all contributed to the experience and understanding of all delegates. We have to carefully manage and defend and preserve the integrity of parks worldwide, so that they are passed on enhanced or unharmed to succeeding generations for their enjoyment and enlightenment.

# Meeting of IFPRA Asia Pacific Region Commission

This was held in Adelaide on Tuesday 2 October 1990. The following notes are from the minutes of the meeting.

#### 1. Representation

Three Commissioners from the IFPRA Asia Pacific Region attended the Inaugural meeting - Trevor Arthur (Australia), Ralph Boggust (New Zealand) and Farley Ma (Hong Kong). Two countries were represented by proxies-Dr Kanzo Hirano proxy for Dr A. Sato of Japan and Roger Brown (IFPRA President) proxy for G. Bradbourne, Immediate Past President (New Zealand). This gave a quorum of 5 as required by the current Constitution. Roger Pollard, President-elect declined to take part in the voting of the meeting as he wished to remain impartial.

#### 2. Election of Office Bearers

Although small in number, the Commissioners and proxies present represented 85% of IFPRA membership of the region. However it was decided not to proceed with the election of the office bearers. Trevor Arthur was to remain as Acting Secretary. Nominations would be called for office bearers again in 1992 (a meeting of the IFPRA Asia Pacific Region will be held during the Hong Kong IFPRA World Congress).

#### 3. Inaugural Asian Congress of IFPRA Asia Pacific Region

It was unanimously agreed to hold the next Congress of the Region in Japan in 1993, and which would be at the time of the 120 years anniversary of the beginning of park administration in Japan. IFPRA Japan and the Park and Recreation Foundation of Japan will organise the Congress with support from Government departments, municipalities and other organisations. The Region was to be given a guarantee of receiving a minimum of \$3,000 (Australia) for its funding as a result of the Congress.

I am sure it will be an excellent Congress and all members are asked to make every effort to be there and to encourage others to attend.

#### Meeting of Assembly of Asia Pacific Region

About 26 members of the IFPRA Asia Pacific Region, along with 38 observers attended the inaugural assembly held on Wednesday 2 October 1990. Following an introduction to IFPRA and its history by the President, Trevor Arthur took over the chairmanship of the meeting.

Fortunately for the Acting Secretary, the meeting agreed to use English as its official language for the Region and the secretariat is to remain in Melbourne. (A list of Asia Pacific countries will be included in the next circular.)

My special thanks to John Brandenburg who acted as Minute Secretary for both the Commission and Assembly meetings.



### The Ornamental Plant Collections Association, Victoria Australia

INTRODUCTION - In my home state of Victoria, Australia, an Ornamental Plant Collections Association (OPCA) has been set up to try to ensure that many fine garden plants are not lost to mankind as has often happened in the past.

Modeled to a certain extent on the National Council for the Conservation of Plants and Gardens in Great Britain, the OPCA aims to maintain and eventually increase the diversity of ornamental garden plants available in Victoria, by registering reference collections of various plant taxa. Each collection will act as a reservoir for particular groups of species, varieties and/or cultivars and thus help to ensure their continued existence.

ROLE OF MELBOURNE ROYAL BOTANIC GARDENS - The Royal Botanic Gardens has provided much active support, helping with identification of plants, providing office space and assisting part time and volunteer staff in many ways. Several senior staff are on the Association's committee along with representatives of various organisations connected with horticulture. Grants have been made by the Nurserymen's Association of Victoria, the Garden State Committee, the Australian Institute of Horticulture and a number of private donations.

REGISTERED COLLECTIONS - Some twenty-three collections have been registered to date and range from Eucalypts to Japanese Cherries, from Banksia to Crocus.

MEMBERS AND SUBSCRIBERS OF THE OPCA - The Association comprises members who are technical/scientific experts who decide which collections should be registered and are responsible for the quality of the collections. The subscribers are the enthusiasts who may be registered collectors, supporters, collectors of rare plants or just interested! They have regular meetings, lectures and field days.

Volunteer staff help with secretarial work, compilation of a small magazine Genus, photographing collections and computerisation of records.

CONCLUSION - It is hoped that this scheme will spread to all States so that plant resources are not lost and the value of the plants is properly recognised. It is also hoped that proper and continuing funding will be obtained to ensure the program is maintained and expanded.

Perhaps other countries may be interested in implementing a similar scheme. Further information could be obtained from the Acting Secretary.
