PAYMENT

VOLUNTARY CANCELLATIONS

Voluntary cancellations received in writing within 90 days or more before advertised event start will receive a 100% refund less an administration fee of \$100 ex GST. Voluntary cancellations received in writing within 60 days before advertised event start will receive a 50% refund less an administration fee of \$100 ex GST. No refund will be given within 30 days before advertised event start; however, an alternative delegate may be substituted. COVID CANCELLATIONS

CONFERENCE POSTPONMENT

Parks and Leisure Australia may cancel or postpone the Conference due to circumstances beyond its reasonable control, including but not limited to Acts of God, terrorism, war, strikes or industrial action, fire, explosion, inevitable accident, breakdown of property, changes in law, pandemics or global health crises. Due to the nature of the event, it may be reasonable to postpone the event to a later date or the following year.
