IFPRA 1977 DURBAN.

Greetings from the IFPRA Congress office in Durban.

It is a pleasure for me to address this first bulletin to you as I have felt for some time now that I should be responding to those members of IFPRA and others who have submitted their provisional registration forms (some 76 to date) to me. Forms from prospective delegates have been recorded and they are now on the mailing list for all pre-congress literature.

I would also like to take this opportunity to thank my colleagues around the world for their Christmas greetings and messages of goodwill in connection with the Congress.

May I draw attention to a slight adjustment which has been made to the dates for the Congress i.e. we now plan to start and finish a day earlier than anticipated in my article which featured in "Recreation Canada" during the Vancouver 1975 Congress. The new dates therefore are, 16 - 22 October 1977 with the Elangeni Hotel, Marine Parade, Durban, as the venue. The registration of delegates will commence on Sunday 16, with the opening of Congress on Monday 17 and continuing through to Friday 21 October, 1977.

A post-congress tour, primarily for overseas delegates, will depart from Durban on Saturday 22 October when participants will be taken to Port Elizabeth, through the Garden Route to Cape Town and thence to Kimberley, Johannesburg and Pretoria, where the tour will conclude on Wednesday 2 November 1977.

Short optional tours have been planned for those who may wish either to arrive ahead of Congress or to stay on after the conclusion of the tour.

The estimates cost at this stage for a delegate (a member either of IFPRA or of an affiliated association) arriving in Durban on 16 October and departing on 22 October 1977 (Accommodation includes bath at bed and breakfast tariff rates) is R200,00 (single) and R175,00 (shared) inclusive of Congress registration fee.

The estimated cost of the post-congress tour, 22 October - 2 November, 1977, inclusive of all accommodation - with bath - at bed and breakfast rates and travel by air and road, is R410,00 (single) and R350,00 (shared).

The Congress registration fees mentioned above are as follows: members of IFPRA and of affiliated associations R85,00 per delegate; ladies R60,00 per lady; and non-members R100,00 per delegate.

When you have studied the contents of this bulletin, and should you be interested, I wonder if you would write to me so that I can place your name on the list of prospective delegates. Questions, comments or suggestions will be appreciated.

HORIZON 2000 AD

Kenneth Morgan, Secretary of IFPRA writes about the 1977 Durban Congress and the country he recently visited.

The International Federation of Park and Recreation Administration, in association with the Institute of Park and Recreation Administration (Southern Africa) will be holding the next Congress in Park and Recreation Administration, with the theme 'Planning for Recreation and Leisure - Horizon 2000 AD', in DURBAN, SOUTH AFRICA, from 16 - 22 October, 1977, during which period the sessions will be held at the Elangeni Hotel (Congress headquarters hotel), on the Indian Ocean shoreline.

The post congress tour, from 22 October to 4 November 1977, will follow the famed Garden Route from Port Elizabeth to Cape Town, via East London and thence to Kimberley, Johannesburg and Pretoria. Travel will be by air and coach.

During the period at Durban five authoritative papers will be presented by experts in their field, from such countries as South Africa, Great Britain, U.S.A., Canada and Australia. In addition, there will be workship sessions led by representatives from, it is hoped, Holland, Germany, Canada, Australia, Great Britain, France, South Africa and the U.S.A.

The week at Durban will be completed by a trade exhibition and visits to parks and recreation facilities in Durban - a city with high standards; to Pietermaritzburg, Natal Parks and the resort and game park at Midmar Dam. Opportunity to meet colleagues worldwide, and to discuss parks, recreation, amenity and leisure provision informally, will be provided by three social occasions.

But what about the cost? It is competitive.

IFPRA member, R200,00 (single) R175,00 (shared), covers room, bath and breakfast inclusive of Congress registration fee.

Post Congress tour, R460,00 (single) R400,00 (shared), covers room, bath and breakfast inclusive of air and road travel.

The Congress registration fees mentioned above are as follows: IFPRA members and affiliated association members, R85,00 per delegate Non-members R100,00 per delegate. Ladies R60,00 each.

But what about the country? It is fascinating.

The cities are, of course, much the same as elsewhere in the world; much recent development, tower blocks, high speed road patterns, quality shopping facilities and good hotels. Civic pride is in evidence. Park and recreation provision is well

ADDRESS TO COMMISSION

Presidential Address by Professor Norbert Schindler

In my capacity as the outgoing President of the International Federation of Park and Recreation Administration (IFFRA), it falls to me to have the honour to welcome you most cordially to this Congress 1983.

Cur professional mission is to provide parkland areas for health and recreation and to enhance the general quality of life and wellbeing of our fellow human beings. Cur efforts in this direction have always been highly valued and have enjoyed much support over the past two decades.

Our aims have been recognised internationally, particularly in the more prosperous countries. Support has been forthcoming, not only from members of the general public, but also from those in influential political circles. Much has thus been achieved in the general acceptance of cur aims and in the improvement of facilities. Financial aid for projects has grown side by side with the financing of the other public services.

We have understandably found satisfaction in the civic development of green areas parkland areas - and in the provision of recreational opportunities. For my part I have striven to promote progress in our profession as an officer in parks provision in various cities and towns and I wound up my professional career in the City of Berlin. Leisure parks have become established as an accepted way of life, well appointed pools have been provided as have imaginative play areas for children. With the standard of provision ever improving, larger and progressively more luxurious garden shows have been planned and presented giving pleasure and enjoyment to many members of the general public.

In retrospect, perhaps the heady pace of the highly successful decades 1960-1970 and 1970-1980 was too fast. The IFPRA Congresses in these years saw tours of Britain, Holland, Austria, Switzerland, Australia, South Africa, Canada and three years ago Berlin and Test Germany. Venues provided impressive proofs of activities in public parks appreciation and of what can be achieved in parkland areas and in the promotion of public welfare. No matter how the merits of 'orderly-planned gardens' or 'natural greenland' or of 'planned recreational areas and facilities' or 'wide open spaces for rest and re-creation as well as recreation' may be regarded, and some are all maybe necessary depending upon other factors, the fact remains that public purse strings are tightly tied at the moment. We are committed on the one hand to cutting costs and on the other hand to expanding and improving the quality of leisure provision. Not an easy task.

Newly laid out parklands have frequently ignored the natural local advantages which could have contributed effectively to provision of the desired facility, even though to ignore the natural advantage goes against our principles. Whether it is intentional or accidental, to do so is unhelpful and is realised as such in town and countryside provisions. Or we have given away too readily to other demands upon land, such as those for road construction programmes. The reasoning behind such planning programmes has undoubtedly been the consideration of the eventual economic advantage.

Perhaps we have not always put undisturbed natural beauty in its proper perspective. Ground preparation, plant choices and ground maintenance perhaps are areas where outlay on labour could be spared to give a better use elsewhere and at the same time allow some element of variety in the conventional parks layout.

Perhaps also we have hitherto undervalued the assistance of the general visitors for whom the facilities after all are provided, and some initiation and encouragement in that quarter could be productive. Only by trying can we find out.

Another emerging factor is the requirement of a multi purpose use of local authority parkland. Indeed this is the thene of our present conference. Such purpose could itself make facilities more cost effective providing it is clearly kept in mind that damage and destruction of parkland facilities and growth has to be kept in check.

These are only some observations but matters do not stand still, solutions will have to be found and all comments will be considered.

This opportunity should not be missed to comment upon our own activities as an organisation itself, as well as upon our conferences.

The IFPRA was founded on the initiative of our British colleagues in London in 1957. It enbodies over 25 national associations and over 250 individual memberships from approximately 35 nations. Our conferences have been held on average every two years up to this one, our thirteenth, being in Barcelona, and at the moment we have a conference planned every three years.

Our meetings have been held in North, South, East and West, and have given valuable professional encouragement. Such meetings provide experienceexchange opportunity that otherwise seldom exists.

The value of such a mass knowledge and experience has attracted the attention of UNESCO, and in Europe, consultation has been had with European governmental bodies. IFPRA members would do well to cultivate such important links. The founding of IFPRA-EUROPE, the European sector of our organisation, in The Hague last year can only bode well for future important contacts.

This does not in any other way amend the Statute whereby Members of the Commission are elected at the General Assembly of Congress.

An item to come before the Commission which is not on the Agenda is the proposal to elect Professor Norbert Schindler, currently President of IFPRA, to the post of Honorary Member of IFPRA. It is intended that this item will be placed before the Commission as a recommendation to the General Assembly. All Members of the Commission who are eligible to vote, have been notified.

You will note from Minute number 86/13 the 1989 Congress is to be held in Greensboro, North Carolina, and the President Elect Roger Brown has recently informed me that the dates of the Congress will be from Sunday 30th April to the 6th May, with a Reception on Saturday 29th April. The Congress Hotel will be the Sheraton Greensboro, and very favourable room and meal rates have been negotiated.

Further information on the Greensboro Congress will be circulated as soon as possible.

I have recently received lists of potential members from some national bodies and I am currently writing to these persons inviting them to apply for membership.

Dear Sir,

I have been requested by my Council to write to you following our recent meeting when the subject of the Secretaryship of the International Federation was fully discussed.

INTERNATIONAL FEDERATION OF PARK AND RECREATION ADMINISTRATION

You will have recently received from the President of ILAM, Mr. Les Cullen, a letter indicating that ILAM Council have at last recognised their neglect of IFPRA brought about by the sudden death of Kenneth Morgan and two Secretaries in a short space of time. My belief is that in fairness to ILAM they require the undivided attention of their full-time Secretariat to develop the new Institute following the merger of four professional organisations. As a founding Councillor for ILAM and serving on working groups prior to amalgamation I am only too well aware of the tremendous energy needed of both full-time paid officers and voluntary assistance from Members to make a success of the merger.

On Kenneth's death I pleaded with ILAM Council to agree to appointing Laurence Holmes to the post of Secretary to the International Federation basically for two main reasons.

- Laurence Holmes undertook all the administrative work for the Federation under 1. the direction of Kenneth Morgan for very many years and continued to do so after Kenneth's death (and subsequently under the direction of John Tressman and Stuart Thornton, our two short-lived Secretaries).
- Laurence has gleaned a lot of valuable knowledge about the Federation over the 2. years and has always shown a keen interest and enthusiasm for his work with the 1 Federation.

When Andre Raad - Netherlands wrote to Members earlier this year offering to take on the Secretariat and train a Dutch colleague to succeed him I supported the possibility in order to keep the Federation alive and flourishing rather than let it die a natural death through insufficient interest.

ILAM's letter of the 28th April recognises that in the best interests of the Federation it is essential to have a firm base with continuity and have now agreed to the Federation's former request to appoint Laurence Holmes. Apart from "the benefits of Laurence's knowledge and interest for the Federation previously referred to, I believe that with the new computer system being installed at Lower Basildon Headquarters of ILAM and the ready access to many overlapping interests and activities, the Federation would be best served by appointing Laurence Holmes as their Secretary. I know he will continue to serve the Federation with diligence and care and more enthusiasm if he takes on the full responsibilities which he has done unofficially for many years.

At the frequent meetings of The Dutch Association of Park Directors (an affiliated member of the IFPRA) I have heard that the federation has gained many new members in the Netherlands.

As the immediate past chairman of IFPRA-EUROPE, I am regularly approached with the comment that there is actually little to show that a world organisation exists.

The members do receive regular evidence of IFPRA-EUROPE's activities, in the form of bulletins containing all kinds of information on IFPRA, trade reports, season's greetings and- of exceptional importance- correct replies to questions put to the secretariat.

As the Vice Chairman and former Chairman of IFPRA-EUROPE, and a member of the IFPRA Commission, I personally was not best pleased to find that my name was not included on this very carelessly compilded membership list, while I did receive a demand for payment of my contribution. Even the honorary member Mr.Schindler of Berlin was omitted from the membership list. I regard these as unforgivable errors which should not occur.

Since the death of Ken Morgan I have lost confidence in the ability of the secretariat at The Grotto to perform its duties satisfactorily and fear that this will damage the presentation of our federation and moreover, will restrict its growth.

As I mentioned earlier, I do have a high regard for the performance of the IFPRA-EUROPE Secretariat.

The secretary, André Raad, shows great dedication. He is an old hand in the IFPRA, has, I believe, been a member of the Commission for 30 years, is past president, has attended every congress and together with Ken Morgan, drew up the statutes to replace the illegible and unusable old ones in 1975. Furthermore, he gave me enthusiastic support in the formation of the European sector.

In short, I feel it would be better to place the secretariat of IFPRA in his hands than to leave it in those of The Grotto.

You have already been informed of the above through a copy of the letter from André Raad to the President, Graham Bradbourne, which was sent to you last year.

For the secretariat of IFPRA-EUROPE, André Raad already enjoys the valuable assistance of Mariette Edelman, also an IFPRA member and PR Officer of The Hague Department of Parks and Environmental Education, of which I am a former director. Mariette and the present director of the department, Harry Wals, would be happy to offer the secretariat every assistance, and it would then be assured of the facilities of an office by modern methods.

While it is of course always painful to have to make condemnatory judgement of a secretariat (and therefore its staff), I nevertheless feel this is necessary in this case.

It is important that IFPRA as an organisation should have an efficient and accurate secretariat in which the members can trust and which, above all, has a stimulating effect.

The fact that the Durch membership has already grown to 34 as a result of the enthusiastic efforts of André Raad, despite the very limited financial resources available to him as secretary of IFPRA-EUROPE, which means that he does all this work as an unpaid volunteer, speaks for itself.

I therefore warmly recommend the nomination of André Raad as secretary of IFPRA, and submit this proposal for consideration by the Commission at its meeting in June this year in Innsbruck.

SUBJECT: Post-Congress Tours

The detail brochure for registration for the 1989 IFPRA Congress will be placed in the mail about October 20 to approximately 150 individuals who have requested detailed information about our 1989 IFPRA Congress. Additional brochures will be sent to each of you so that you may share it with others who may not have requested the information.

I received today the detailed information concerning our post-congress tours. I am including the information here so that you may be able to respond to any inquiries prior to receipt of the detailed brochure.

As I indicated, we planned and will offer two tours to our delegates. In the event that there is not a sufficient number of delegates to sign up to fill both tours, we will combine the tours and make the one with the most delegates who signed for it. Both tours are outstanding and I am certain that the delegates will enjoy either equally as well.

We will attempt to arrange some social hours and evening meals in some of the cities where we will be staying. While we cannot guarantee that this will take place, we are certainly going to make every effort to do so.

You will note that the delegates will not be returning to Greensboro. Our travel agency who worked with us (American Express) determined that it would be less expensive for the delegates to fly from either Orlando or Philadelphia than coming back to Greensboro. We will make the decision by January 15, 1989 based upon the number of delegates signed up for the post-congress tours as to whether both tours will be taken or whether only one will be taken. Delegates who have signed up for the tours as of January 15 will be notified by airmail immediately after that date so that they can buy their airline tickets with the proper departure city from the United States.

We decided to offer both tours because a number of delegates whom I talked with in Innsbruck indicated a considerable interest in the southern tour to Disney World and to the northern tour to the Washington, DC area. We certainly hope that there will be a sufficient number of delegates interested in both tours so that both can be held as planned.

Please be aware that this registration fee includes all meal costs beginning with the evening meal on Sunday, April 30 and ending with breakfast on Saturday, May 6. The only other expenditure that delegates will be required to make after arriving in Greensboro is for hotel accommoda-tions and any personal items that they wish to purchase. The hotel room rate of \$71.28 includes all taxes and is for one or more persons sharing the same room. In other words, if you share a room with a colleague and split the cost it will cost you \$35.64 per night for each of you. Also, if you share a room with your spouse, both of you can stay for \$71.28 per night. The registration fee for accompanying persons is \$275. 

Dear World Commissioner,

Enclosed are copies of the Minutes as prepared by the President of the recent meetings in Greensboro, together with the latest issue of the Bulletin and details of members in your country whose subscriptions are outstanding.

It was resolved at Greensboro to ask the World Commissioners to endeavour to encourage members in their country to pay any outstanding subscriptions. It was further resolved that any subscriptions due in respect of the period prior to 1st April 1989 and remaining outstanding at 31st August would result in suspension of the member. In future, if any subscriptions are outstanding for more than twelve months, this will result in the automatic suspension of those members. In consequence, any member who has not paid his 1988/89 subscription by 31st August, 1989, or his 1989/90 subscription by 31st March, 1990, will be suspended. If the Federation is to thrive and extend its activities, it is necessary to have a a wider and more extensive membership base. Once again, it is in order for you to collect the initial subscriptions of new members and forward them to me, together with a completed application form, or for prospective new members to send their application forms and initial subscriptions direct to me.

It would be helpful if you would make enquiries within your own country to ascertain whether any city would be interested in hosting the IFPRA 1995 World Congress. If interest is expressed, please apply to me for further information and details of requirements.

Copy for the next edition of the Bulletin is required as quickly as possible, as the closing date is the end of February. The closing date for copy in respect of the following edition will be the end of May.

In order to reduce the cost both to yourself and to the Federation of paying subscriptions, I can advise you that all payments should be in sterling. If they are not, bank charges are incurred in addition to exchange costs. The preferred method of payment is by a sterling cheque from a bank outside the UK, via a London Clearing Bank. If this method of payment is followed no charges are involved. Most membership subscriptions are paid by this method.

There are two other methods which avoid bank charges. The first is the use of eurocheques, but transfers by this method take longer to clear through the system and involve the payer in the completion of a number of forms. The second is the direct credit of IFPRA's UK bank account and provided that the payments are in sterling, this method will incur no bank charges. However, there is a danger when payments are credited direct that insufficient information will be forwarded with the payment to enable identification of the payer.

May I take this opportunity of wishing you all a very happy and successful 1990.

FINANCES: The financial stability of our organization is better. Due primarily to the financial success of our 1989 Congress in Greensboro, a contribution to IFPRA in the amount of £2500 was made. This was in addition to the £12 per delegate capitation fee that had already been made.

Additionally, a six-year pre-payment of the £75 Corporate subscription for the National Recreation and Park Association of the United States and for the City of Greensboro Parks & Recreation Department was also made.

A Presidential Travel Fund was also established in the amount of £2300 and therefore will show on our records as a restricted account. Future presidents may also add to the account for this purpose if it is beneficial for them to do so.

This financial stability allows us the opportunity to develop a financial plan to finance our growth, programs, and organizational security. Our Finance Committee Chairman, Roger Pollard, will be working with the Committee and General Secretary to develop this program for Commission review and discussion.

MEMBERSHIP: As of 20 April, the records indicate we have 215 professional members. Our special thanks to Andre Raad for his hard work in the collection of subscription fees and recruitment of members through IFPRA Europe. It is hoped that the IFPRA-Asia/Pacific Congress in Adelaide and a preliminary meeting in Tokyo will add new members. Let's not forget that we have a goal to reach a professional membership of 400 by our 1992 Congress in Hong Kong. If each member would secure just one new member, we would reach that goal easily. MEMORANDUM FOR MEMBERS OF THE IFPRA COMMISSION

Financing of IFPRA Regions

PURPOSE

To seek Members endorsement of a new code of practice. for financial provision and accountability in IFPRA Regions to take effect from 1 April 1991.

BACKGROUND

2. At its meeting during the Berlin Congress of 1980 the IFPRA Commission agreed to set up its first Regional body - IFPRA Europe. Andre Raad was elected to Chair the new body and Kenneth Morgan, then General Secretary of IFPRA, was elected to be Secretary of IFPRA Europe also. With the death of Mr. Morgan in early 1982 Andre switched to the Secretary role (and remained since) with the chair eventually being taken by Hank Bos at the first IFPRA Europe Congress.

3. To finance the new Region the IFPRA Commission made a 'start-up grant' of ±200 and approved a ±20 supplementary levy each year on Affiliate Members of the Region. A capitation fee the Region of ±2 per head was also authorised for IFPRA Europe congresses. A revised set of statutes including a section on Regions was issued in 1984 (see attached copy of the new Section). This included provision for IFPRA to make grants to the new Region to assist its work but otherwise made no provision for regular funding nor accountability to IFPRA World for the financial actions of the Regions. This situation has remained unchanged to the present day apart from an interim funding package agreed at Greensboro in 1989.

4. Therefore the 'provisional' funding measures adopted in Berlin have, in effect, been allowed to become 'permanent'. The effects of this can be summarised as follows :-

- (a) the lack of financial incentives resulted in professional, retired, corporate and supporting memberships only growing marginally in the years 1980-1988 despite two World Congresses and three European Congresses being held in Europe during that period.
- (b) the supplementary ±20 levy on top of the already considerable Affiliate fee (now ±75) has effectively stifled any increase in Affiliate membership.

- (c) the small size of capitation fee for Europe Congresses has proved to be of marginal benefit to the Region over a 3-year period.
- (d) the true value of income has declined due to the effects of inflation.
- (e) due to the severe lack of finance the Region has not been able to pursue its objectives to the extent originally envisaged.

5. The widening gap between available finance and high aspirations first came into focus at the IFPRA Europe Congress in Innsbruck in 1988. On that occasion the IFPRA Commission was requested to redeem a substantial personal loan to keep IFPRA Europe functioning in 1988/89 and 1989/90. As most Members of the Commission, including the President-Elect and General Secretary were unaware of the financial state of IFPRA Europe the issue was cause for much disquiet, this surfacing again in Greensboro the following year.

6. The Greensboro Congress in 1989 was critical because it became apparent to all that IFPRA finances were in a generally unstable state and that the IFPRA Commission, in previous years, had failed to address the deterioration in membership and financial affairs. However, with resources very limited and the need for time to evaluate both the problems and the remedies the best that could be done for IFLEX Europe was a short term 'rescue package' based on incentives to recruit. This move allowed the Region to survive in satisfactory manner but, as anticipated, reserves are now beginning to run low. It is therefore imperative that a completely new set of practices must be put in place not later than 1 April 1991 and <u>prior</u> to the next formal meeting of the IFPRA Commission.

THE PROPOSALS

 \bigcirc

7. Following detailed discussions between the President, President-Elect, General Secretary and the Secretaries of IFPRA Europe and IFPRA Asia-Pacific the following package of proposals is commended. These proposals are based on the assumption that, in future, IFPRA World will be the direct source of most Regional income and this will necessitate due accountability for disposal of funds. The measures proposed are as follows :-

(1) The Regions will levy a capitation fee of between ±10 and ±20 on all delegates attending Regional Congresses the actual figure chosen being subject to need. The levels of capitation fees for Congresses will be reviewed at all future World Congresses. Where Congresses are held jointly with national conferences capitation fees will only be levied on IFPRA Members and accompanying persons (local or overseas) plus representatives of IFPRA group members.

- (2) On receipt of subscription fees IFPRA World will provide its Regions with a 50% rebate on <u>first</u> subscription fees received from <u>new</u> members in <u>all</u> categories. The timing of such rebates will co-incide with that indicated in 7(6) below.
- (3) IFPRA World will provide the Regions with a 50% rebate on all subscription fees paid in <u>each</u> of the <u>subsequent</u> years by Corporate, Affiliate and Supporting Members within the respective Regions.
- (4) Regions <u>may</u> request the General Secretary of IFPRA to levy a supplementary fee on the annual subscriptions paid by individual (non-group) members of IFPRA within the respective Regions. This will be subject to the size of increase <u>not</u> being in excess of 25% of the 'World' fee and that the request is placed not less than three months before the start of the financial year effected.
- (5) Regions may <u>exceptionally</u> seek (by not less than three clear months notice in writing, addressed to the General Secretary), a grant from IFPRA World to sponsor special initiatives subject to endorsement by not less than two thirds of the IFPRA Commission or, alternatively, two thirds of Commission Members present at a 'World' Congress. However Regions may seek and receive sponsorship from other sources independent of IFPRA World providing such sums received appearing in the accounts of the Region.

Special Conditions

E

- (6) The General Secretary shall, within seven days of commencement of a new financial year, advance to Regional Secretaries a sum equivalent to 35% of the annual income calculated to arise from (3) above. This calculation will be based on the total paid-up group membership of the Regions current at the start of the last month in the old financial year. Additional sums will be paid quarterly (i.e. on or about 1 July, 1 October and 1 January each year) based on the subscription income exceeding the advance payments made in April.
- (7) The Regional Secretaries will forward professionally audited accounts to the General Secretary within three months of the financial year concluding and in a format similar to that used for IFPRA World accounts. The General Secretary, for his part, will provide an annual statement to the Executive Committee and the Commission on World and Regional finances with appropriate remarks and recommendations.

7(8) Other than the measures specified in 7(1) - (4) above no additional levies may be placed on individual or group members of IFPRA nor any loans or other forms of indebtedness be entered into without a two thirds majority vote in favour by postal circulation of the IFPRA Commission or alternatively a two thirds vote in favour by Commission Members present at a World Congress.

FINANCIAL IMPLICATIONS

8. If the proposals in paragraph 7 are to be applied to <u>IFPRA Europe</u> in 1991/92 the potential benefit to the Region, based on advised membership in mid-October 1990 and in anticipation of the IFPRA Europe Congress in Orleans in September 1991, would be :-

(a)	Capitation Fees from IFPRA Europe Congress = 150 delegates x ±10 - 3 years	=	Ŧ	500
(b)	Rebate on new members (sample) = 5 x \frac{1}{5} + 20 x \frac{1}{5} = \frac{1}{695} x 50%	=	Ŧ	348
(c)	Rebate on group membership fees = 42 members x ₤75 x 50	=	 ∎1,	,575

Total income ±2,423

N.B. the initial payment under paragraph 7(6) above would therefore be ±551 on or about 1 April 1991. This would be supplemented in <u>future</u> years by the ±500 + available from the Congress capitation fees giving an excellent cash flow situation for the Region. The income from (b) would of course depend on how successful the Region is in recruiting new members.

9. For <u>IFPRA Asia-Pacific</u> this would not take effect until after the Hong Kong Congress. To complete the 1992/93 financial year the Commission may prefer resort to a 'one-off' grant to Asia-Pacific followed by implementation of the new system as from 1 April 1993. As far as can be ascertained at this stage, income for IFPRA Asia-Pacific from these proposals is likely to be broadly similar to that for IFPRA Europe. With increased financial freedom it is anticipated that membership in both regions is likely to grow for some time to come to the benefit of IFPRA World also.

RECOMMENDATION

10. Since Greensboro, in May 1989, the paid-up membership of the Federation has more than doubled and the income almost trebled. Coupled to sound financial provision in Greensboro the accounts of the Federation are now in a much healthier state and provide a long-overdue opportunity to remedy defects in the present funding provision for IFPRA Regions to allow their orderly development.

- 11. Commission Members are accordingly recommended to :-
 - (a) suspend Sections 8.06, 8.07, and 8.08 of the attached IFPRA Statutes as from 31 March 1991 until further notice as permitted under Section 5.03(b).
 - (b) approve the package of proposals contained in paragraphs 7(1)-(7) above to take effect on 1 April 1991 (IFPRA Europe) and at a later date to be chosen by the IFPRA Commission for IFPRA Asia-Pacific.

PRESENTATION

12. This paper is submitted for urgent consideration and decision by all members of the IFPRA Commission. The closing date for returns to reach the General Secretary is <u>15 January</u> <u>1991</u> after which date Members not responding <u>will be assumed to be in favour of the recommendations at paragraphs 11(a) - (b).</u>

While I have not had correspondence with many of you during these past few months, there has been much activity associated with IFPRA about which I wish to bring you up-to-date. I am very pleased to report that our organization is very active but most of this activity has been associated with our internal operations and organization. As I have indicated in the past, I am devoting most of my efforts toward placing our organization in a position of financial stability with appropriate procedures and processes that will enable us to begin to focus on some of the external issues with which we should be involved. When President-Elect Roger Pollard takes over at the Hong Kong Congress in 1992, it is my desire that he will be able to spend his efforts focusing on those external issues that we as professionals and as an organization feel strongly about.

1. <u>NEW COMMISSION MEMBERS</u> - We are pleased to welcome two new members to our Commission representing the United States and Hong Kong. These new members are added by the authority of the statutes which permit the countries of the President and President Elect to name representatives to the Commission since their representatives are now officers representing the overall organization rather than their country. Farley Ma is the representative of Hong Kong and is the Principal Amenities Officer of the Urban Regional Council. James (Jim) A. Peterson of the USA is a retired professor from Indiana University in the Department of Recreation and Park Administration. Recreation Association, the National Recreation and Park Association of the United States, the World Leisure and Recreation Association and the International Federation of Park and Recreation Administration. This special one-day meeting allowed for major information exchange and discussion of common problems and areas of mutual interest and cooperation. It is anticipated that there will be opportunities for follow-up meetings of the group, as well as an opportunity to include other national organizations.

- 6. <u>IFPRA WORLD STATUTES</u> Trevor Arthur, Chairman of the Special Statutes Committee, is continuing to make progress with revising our statutes. It is anticipated that the Committee will complete a preliminary revision in time for the draft to be sent to Commission members prior to our meeting in Orleans, France. Considerable time will be allowed at that meeting for discussion of the draft and to provide further direction to the Committee, if necessary, in order that action can be taken at our meeting in Hong Kong.
- 7. <u>COMMISSION MEETING IN ORLEANS, FRANCE</u> As we agreed at our meeting in Greensboro in 1989, the Commission ŵill hold its next meeting in Orleans, France, as part of the IFPRA Europe Congress. The dates of the Congress are September 2 5, 1991, and the Commission will meet the preceding day (September 1, 1991) with the anticipated time being 2000-2300. A complete agenda, along with appropriate back-up information, will be mailed to you in advance of the meeting so that we can accomplish as much as possible at our meeting. Please mark these dates on your calendar and make every effort to be in attendance.
- IFPRA MEMBERSHIP President-Elect Roger Pollard, who also 8. serves as Chairman of our Finance Committee, sent to the Commission members an analysis of our membership since our meeting in Greensboro. I am certain that you are as pleased as I am that our membership has shown dramatic growth. After purging our membership records of unpaid members following our meeting in Greensboro, we had a little over 150 paid-up The analysis showed that we have greatly increased members. our dues paying members to over 350 at the present time. IFPRA Asia-Pacific, IFPRA Europe and the United States are greatly responsible for our increases. Our goal of 400 prior to the Hong Kong Congress in 1992 is certainly within an easy reach and I would hope that our membership would exceed 500 by 1992. Please keep up your good efforts and follow up with your membership in your countries to assure their continued support of our organization.

- 2. A draft agenda has been prepared for our Commission meeting in Orleans'. This preliminary agenda is being forwarded to you by the General Secretary at this time for your information. It will not have attached the supporting documents that the final agenda will have. Due to the limited amount of time that we have for our Commission meeting, the agenda focuses on those items that are essential for discussion and action. Other agenda items that have been proposed will be placed on the agenda for our meeting in Hong Kong in 1992 when we will have more time.
- 3. The General Secretary has recently sent to you the membership records for your Country. We are beginning to experience some increase in delinquent memberships again and each of us needs to place a high priority on retaining our current members as well as adding new ones to our organization. We are within reach of our 400 goal by the Hong Kong Congress and I urge all of you to give importance to this request.
- 4. As part of our emphasis on the establishing of guidelines and policies for the internal operation of IFPRA, Roger Pollard has prepared several discussion papers that focus on many of these issues. IFPRA Statutes

Following receipt of requests from several members of the IFPRA Commission I am re-issuing a copy of the current IFPRA Statutes which you may find to be of assistance in discussing present and future IFPRA procedures.

The attention of Members is drawn to Section 8 of the Statutes where an approved paper on regional funding necessitated suspension of three of the existing statutes in order to proceed with the new financial arrangements. Those are marked accordingly.

Furthermore, in Greensboro, Members voted to explore legal incorporation of IFPRA in the United Kingdom and should incorporation eventually take place the existing statutes would be superceded. Trevor Arthur is leading a working group to develope the documents and procedures required for incorporation and an interim report is anticipated for the meeting of the IFPRA Commission in Orleans. Should incorporation <u>not</u> be carried through with the existing statutes will need updating and be complemented by procedural guidelines governing the administrative processes of the Federation.

With the above concerns in mind Members are asked study and consider the existing statutes as a preliminary to the Orleans discussions.
