### SPEAKER PROFILES

(In order of appearance)

- Mr Peter Nicholls, BA, DipRecPlng: Federal President, Royal
  Australian Institute of Parks and Recreation for 1989/90. Mr
  Nicholls has been a member of the Institute since 1978. He is
  employed as a Recreation Planning Adviser with the South
  Australian Recreation Institute, a division of the Department of
  Sport and Recreation and has been with that Department since
  1976.
- Mr Crosswhite is the Acting Executive Mr Perry Crosswhite: Director of the Australian Sports Commission, which is located at the Australian Institute of Sport. Born in America, Mr Crosswhite came to Australia some 20 years ago. He has worked with the Victorian and Commonwealth Governments for fifteen years in government sports assistance. He played for the Victorian and national basketball teams and competed in three Olympic Games for Australia (Munich, Montreal and Moscow) and captained the team to the 1976 and 1980 Olympic Games. He has played over 150 international games for Australia and competed in six Australian championships with Victoria. His club, Melbourne Tigers, still coached by Lindsay Gaze, now plays in the National League. Crosswhite has undertaken both coaching and administration courses throughout the South Pacific and assists the Canberra Cannons with their hospitality and VIP visitors.
- Secretary, International Association for Sports Mr Vic Watson: Surface Sciences. Mr Watson has worked for 29 years on the research, development and testing of polymeric materials. much of that time, he has specialised in the performance and assessment of synthetic sports and games surfaces. widely, has written many technical articles, and is co-author of the only definitive work of reference in the above field "Polymeric Surfaces for Sport and Recreation", published by Elsevier Applied Science in 1982. He is a director of the independent test laboratory, The Centre for Sports Technology (CST), which is the only testing organisation in the Uk devoted exclusively to the appraisal of synthetic sports surfaces. is also the only independent test laboratory in the world formally accredited by both the Federation International de Hockey (FIH) and the International Amateur Athletic Federation He is a Fellow of the Plastics and Rubber Institute, and has served for over four years as the Secretary of the International Association for Sports Surface Sciences, based in Zurich.
- Mr Young & Associates, which was established in 1982 to meet a foreseen need, both in the public and private sectors, for a competent and innovative approach to design and construction in the civil and hydraulic engineering fields. Mr Young is responsible for the overall performance of the company and is closely involved with all aspects of the company's work. The firm currently has expertise in the areas of urban development, roads, hydrology, hydraulics, sports facilities, synthetic surfaces for sport, irrigation, building hydraulics and site servicing for institutional and commercial developments. The

firm has been involved in many major recreational/sporting facility developments, including the Australian Institute of Sport (AIS) synthetic hockey/soccer field, athletics stadium and warm-up field extensions, State Sports Centre Sydney synthetic surfaced hockey field, Q.E.II Stadium Brisbane synthetic surfaced hockey field and athletics warm-up field, Mararra Sporting Complex Darwin synthetic hockey field and athletics track, and ACT Racecourse master plan for upgrading and extension.

- Mr Keith McIntyre, BSc (Hons), MSc: Mr McIntyre is a Science Officer with the Horticultural Services Unit, ACT Parks and Conservation Service in Canberra. He has had more than 20 years experience in horticultural research and park management. For the past ten years, he has specialised in turf and irrigation.
- Mr Brown, BSc (Hons), GradDipRecStudies: Mr Brown is a member of the Standards Association of Australia's Technical Committees for "Synthetic Sporting Surfaces" and "Safety Helmets for Sport and Recreation Equestrian Helmets". He is also a member of the International Association for Sports Surface Sciences.

  After nine years with the WA Department of Youth, Sport and Recreation in various senior appointments, Mr Brown is currently the Director, Research and Planning, Sports Technology Centre, Margaret River, WA. The Sports Technology Centre is a new and totally independent enterprise which is fully experienced in undertaking investigative studies on design and management issues relating to the planning and development of sport and leisure facilities and services.
- Mr Bob Jones: Mr Jones is Sports Surfacing Manager for Dow Chemical (Australia) Pty Ltd and has been directly involved in sport and recreational construction and surfacing activities in Australasia His initial involvement was with the since the early 1970s. complete engineering design and supervision of the construction and all-weather surfacing of the QE II Chevron 440 track in Christchurch, recognised as one of the top track installations in the southern hemisphere. Following the QE II track was the complete design of a Chevron 440 track at Olympic Park, Melbourne's athletic headquarters. In the late 1970s, Mr Jones designed and supervised the construction and all-weather surfacing of provincial tracks in Hastings and Invercargill. Most recently, he has been involved in the design and installation of a POLYFLEX surfaced athletic track for the Dunedin City Council's Caledonian ground, the complete replacement of several areas of the QE II Park track with POLYFLEX and the installation of a POLYFLEX surfaced track at Penguin in Tasmania. During 1989, Mr Jones was the project manager for the POLYFLEX surfacing of two athletic tracks in Singapore and, subsequently, the design, construction and POLYFLEX surfacing of a track in Papkura, Auckland. last 18 years, he has also designed and supervised the construction of many all-weather tennis courts, gymnasium floors and other sport and recreation areas throughout New Zealand. recent development for which Mr Jones is directly responsible has been the design of a polyurethane bounded shredded rubber shockpad for use under sand-filled synthetic turf hockey fields. To date, six of these fields have been installed throughout Australasia and one in Malaysia.

Mr Terry Fraser: Chief Executive of Supergrasse Pty Ltd. After a career of 28 eight years in the commercial cleaning field, which included the development of the Rocket Vac Back Pac for

commercial cleaning, Mr Fraser joined Supergrasse in February 1990. Supergrasse is a wholly owned Australian company that has been manufacturing synthetic turf for the past 12 years at its totally integrated plant in Sydney and is noted for continuity in excellence of product, quality control and innovation in the research and development of new products in response to market demands.

- Mr Frank Yeend, AM, BComm: Mr Yeend is the Australian Technical Delegate to the International Hockey Federation and has been chairman of the Committee on Equipment since 1985. He is a life and Councillor since 1959), and an interstate hockey player, captain, coach and manager over 22 years, including being a national umpire for 10 years. He was the author and administrator of the international system of approval for synthetic outdoor hockey pitches.
- Mr Robert Mathews: Mr Mathews is General Manager of Balsam Pacific Pty Ltd, the Australian subsidiary of Balsam AG, the leading manufacturer of sporting surfaces in the world, producing 1.3 million square metres of sports surfaces annually. A Fellow of the Institute of Sales and Marketing in London, Mr Mathews has over 20 years experience in the development of sporting surfaces throughout Europe, North America and Asia. He has been instrumental in the installation of sporting surfaces in more than 60 installations throughout the world. His work at this international level of sport provides seminar delegates with a worldwide view of sporting surfaces and their future direction.
- Mr Cole, formerly Managing Director of Omnisport Mr Robert Cole: Australia International Pty Ltd, is now the General Manager Grassport Division, Balsam Pacific Pty Ltd, and is based in Prior to becoming involved in sports surfacing in 1983, he had a background in building, industrial and chemical raw Becoming Managing Director of Omnisport Australia in 1984, Mr Cole's experience in the Sports Surface Industry, especially in the synthetic turf industry, has made him one of the Industry's experts. Omnisport Australia, under his stewardship, has become a market leader with the highest reputation for quality products and service. The recent acquisition of Omnisport by Balsam Pacific is seen as a very positive step, with the joining of these two organisations in Australia leading to the establishment of an organisation totally dedicated to all areas of sports surfacing. Mr Cole's new position with Balsam Pacific will see the ongoing traditions of quality and service continued.
- Mr Denis Wilson, Mengsc, Be (Hons): Mr Wilson is the Vice President of Athletics Australia, Vice President of ACT Athletics, Vice President of the ACT Olympic Council, Oceania member of the Technical Committee for the International Amateur Athletics (IAAF) Federation and member of the IAAF Working Party on Stadium Construction, and International Technical Official Seoul Olympics. He has 40 years of involvement in athletics as an athlete, administrator and official. He was the Chairman of Stadium Construction and Technical Committees for the 1977 Pacific Conference Games and 1985 World Cup. Mr Wilson has been responsible for construction of Australia's overseas chanceries, residential accommodation and recreation facilities.

- Mr Field is one of three directors of A.V. Syntec Pty Mr John Field: Ltd. His experience in the coatings and resin industry started in 1957 and he was the founder of Avee Chemicals in 1973, manufacturing concrete roof tile coatings, distributing fibreglass re-inforced plastics, and later established A V In 1978, A.V. Syntec took up the challenge to Adhesives. develop a playing surface which would perform well under intense use and subsequently developed a range of synthetic alternatives Synpave products have been to traditional sports surfaces. designed for serious players. Mr Field's latest development is with polymer modified cement systems. He manages the Victorian Branch of A.V. Syntec and is responsible for Australian marketing development.
- Mr Fickling: Mr Fickling is the Marketing Manager for
  Astrograss Allweather Surfaces Limited. He spent five years
  with U.E.B. carpets as a cadet studying manufacturing and
  marketing, 16 years with Morgan Furniture initially as a Sales
  Representative then for the last nine years as Marketing
  Director. He has had direct marketing involvements in the UK,
  USA, South East Asia and Australia and has knowledge and
  experience of the manufacture and installation of allweather
  surfaces, particularly tennis, hockey, bowls and cricket.
- Mr Gary Beehag: Mr Beehag has been employed with the Australian Turf Grass Research Institute, Sydney as a Senior Turfgrass Consultant since 1984. His position mainly concerns consultation and extension. Previously, he was employed as a lecturer with the NSW Department of TAFE at the colleges at Ryde, Wollongong and, on a part-time basis, at Padstow. During 1980, he was awarded a Churchill Fellowship to study the turf industry in USA. Prior to this, he was a golf course superintendent in Sydney. Possessing qualifications in Greenkeeping, Horticulture and Pest Control, and with some 16 years of experience in the industry, he has been the author of articles in trade journals and magazines.
- Mr Peter Binns: Mr Binns has worked for the Victorian Cricket

  Association (VCA) since 1983, where he is the Manager Club
  Cricket and Publications. He is responsible for administration,
  operation and maintenance of the State's senior competition (on
  turf wickets), and the Kleenex Cup Competition. Personally, he
  has played cricket for the past 22 seasons and has played on
  turf, malthoid, matting, "carpet" and synthetic grass. He has
  played over 210 senior matches at the Ringwood Club at all
  levels, including several VCA 1st XI matches for Ringwood.
- Mr Casimaty is the Managing Director of Strathayr Mr Bill Casimaty: Instant Lawn Pty Ltd. He is a Dookie Agricultural College graduate and was operating a mixed farm at Richmond, Tasmania, when he won a Nuffield Scholarship. His 1967 overseas study tour enabled him to identify and subsequently, to develop, new crops and agricultural enterprises suited to Tasmania. particular, he founded the Coal River Products Association and the Strathayr Instant Lawn Company. He is also involved in the production of wool, vegetables, small seeds, essential oils and Mr Casimaty is currently a Council Member of the winegrapes. Tasmanian University and Chairman of its Farm Committee; Vice Chairman of the Coal River Products Association; a member of the District Irrigation Committee; and Chairman of both the Richmond Municipal and Rural Fire Brigades. He is also past President of the Tasmanian Oil Poppy Growers' Association. Mr Casimaty's Company has achieved international recognition for its

development of washed turf technology. Major contributions to sports turf have been the development of instant wicket systems turfing (meetings held just three weeks after installation). Hong Kong for the Sha Tin track.

Mr Peter Semos: Mr Semos is the Manager Technical Services with Strathayr Instant Lawn Pty Ltd. He commenced a five-year apprenticeship in horticulture with City Parks, Department of Territories, Canberra, in 1967 and obtained the Horticulture Certificate from CCAE (now University of Canberra) in December In 1972, he obtained the Journeyman Certificate in Horticulture and in 1973 was awarded a Commonwealth Public Service Cadetship as a trainee Technical Officer. the Biological Research Technicians Certificate from CCAE in 1975 and has completed numerous smaller training courses since 1978. His work experience includes employment with the City Parks, Department Of Territories (5 years), the National Botanic Gardens (1 year) and the Horticultural Services Unit (14 years), all in Canberra, and just over three years as Arenas Manager at the Melbourne Cricket Club ground (MCG). Service with the Horticultural Services Unit involved extensive research into turf management practices and turf grass water requirements (including applied research into irrigated and dry land turf grass maintenance); turf grass mixtures and cultivar evaluation; soil testing and interpretation; formulation of soil specifications for cricket wickets, top dressing, playing field construction, bowling greens, golf greens, drainage material and general use; the development of seed sowing mixtures, sowing rates and methods Considerable experience was also of testing seed quality. gained with the development and implementation of fertiliser, top dressing and renovation programs; the evaluation of irrigation designs and equipment testing; the evaluation turf grass care equipment; the evaluation of warm season grasses for sports fields and wickets; the use and monitoring of heating cables on cricket wickets; and the development and use of pre-treated seed for better turf establishment.

Mr William Mortlock, BCom: Mr Mortlock is the Managing Director of Recreational Surfacing Pty Limited. His company has surfaced over 3,500 tennis courts throughout Australia and South East Asia of numerous sporting surfaces and is acutely attuned to the problems facing the industry.

- Mr Taylor: Mr Taylor has been the Executive Director of the Royal Australian Institute of Parks and Recreation since December 1984. Prior to taking up this appointment, he served for over 25 years in the Royal Australian Air Force and retired at the age of 46 with the rank of Group Captain. Significant postings in the later part of his service career included Director of the Office of the Chief of the Air Staff, Commanding Officer of Base Squadreon Fairbairn (ACT) and Chief Instructor at the School of Air Navigation.
